#### **FAMILY SEASONAL MEMBERSHIP – \$195 plus tax**

Entitles range pass holder, spouse and dependents under the age of 23 to unlimited range balls for the season.

Any family member may have a maximum of three bags of range balls at a time.

You may come in and get additional bags after finishing the original three provided.

Any range pass holder caught giving range balls to friends or fellow players will immediately lose their range privileges. No exceptions.

Range balls may not leave the Shoreland Country Club premises at any time.

#### **SINGLE SEASONAL MEMBERSHIP – \$195 plus tax**

Entitles range pass holder to unlimited range balls for the season.

Any range pass holder may have a maximum of three bags of range balls at a time.

You may come in and get additional bags after finishing the original three provided.

Any range pass holder caught giving range balls to friends or fellow players will immediately lose their range privileges. No exceptions.

Range balls may not leave the Shoreland Country Club premises at any time.
